Many doctors are completely unprepared for litigation, even though the majority will experience it during their careers. The experience is shrouded in secrecy and shame, and the individual physician often suffers in isolation, sometimes with disastrous consequences. Gita Pensa, M.D., will discuss the complexities of litigation stress in doctors, its impact beyond legal outcomes, and how education and more effective support strategies for defendants can mitigate its impact. A significant amount of reimbursement is at risk due to the regulatory changes.

- Identify the origins of litigation stress in the physician defendant.
- Recognize the ways in which litigation stress and fear of litigation drive career abandonment, burnout, and suicide in physicians.
- Explore the role of effective peer support, coaching, and education in mitigating litigation stress.

Healthcare professionals should know that whistleblowers represent the vast majority of recoveries, according to Department of Justice statistics. The presentation will discuss the history and relevant healthcare cases involving whistleblowers, including the qui tam career of Cecilia Guardiola, a registered nurse with a law degree who has been paid awards from three different healthcare institutions. In addition, the presentation will address best practices for responding to whistleblowers and law enforcement agencies investigating their allegations.

Learn from a former federal prosecutor and a national healthcare consulting practice lead how to leverage data analytics in defending government actions, as well as using in proactive compliance activities.

Healthcare privacy is a hot mess. There is an increasingly complicated set of laws and regulations impacting how health data can be used in and out of the core system. These rules are confusing, overlapping and often borderline incomprehensible, yet lawyers working in this area have an ethical duty of competence. At the same time—particularly for innovative uses of healthcare technology—there is an increased risk of enforcement and growing concerns about the impact of these rules on a wide range of valuable technology. Business associates, including lawyers holding HIPAA data, have a duty to understand data security risks. Despite these complexities, there are societal benefits and business opportunities for using health data in thoughtful and appropriate ways consistent with these evolving legal requirements. 8:15 – 9:00 am Impact of Private Equity-Owned Physician Staffing Organizations on Patient Safety, Patient Care, and Physician Workforce: A Case Study

Private equity firms have deepened investments in the health care sector in recent years, particularly in staffing firms, on which many U.S. hospitals have come to rely. In March 2024, the U.S. Department of Justice and other federal agencies launched a probe to examine whether private equity interests are damaging healthcare workers, quality of care, and affordability. The panel will discuss private equity's impact on the economically challenged U.S. health care delivery system. Specifically, the panel will discuss private equity's effect on patient care models and the physician workforce, which, in the view of a not-insignificant number of physicians, has led to patient safety and quality concerns as well as questionable/aggressive billing practices. The panel will provide a case study and real-time examples of such practices. Attendees will learn to:

- Recognize the operational realities faced by hospitals that support the engagement of PE-backed firms to meet their staffing needs.
- Identify the opportunities and challenges doctors and APPs face when hospitals choose this staffing model.

The Grass Is Greener - Expanding Access to Alternative Therapies

Medical marijuana is legal in 38 states. This session will explore the always-evolving regulatory structure for medical marijuana.
